AFDPO WILL BE MIGRATING TO A Y2K COMPLIANT WAREHOUSE MANAGEMENT SYSTEM FROM 7 - 30 DECEMBER 1999.

During this timeframe, they will not be accepting routine orders for physical products. The ETS on-line ordering capability will be deactivated and the AFPDC will be closed 1600 hours (EST) on 7 December 1999. They will resume normal operations on 30 December 1999. All customers are strongly encouraged to order, before 7 December, a 30-day supply of physical products that you use on a regular basis. If you have to place an emergency order for products between 7 - 30 December (emergency = a work stoppage would occur without the form or publication), please call the order desk staff at DSN 584-4529/4729/4829, COMM 410-687-3330. They will take your order and process your request. Customers in PACAF or USAFE can contact the Theatre Distribution Offices (TDO) in those locations for support.
